The Pregnancy Resource Center equips women and their families with unplanned pregnancies to make life affirming and informed choices by using biblically based principles to demonstrate the unconditional love of Jesus Christ.

The PRC opened in Rockwall October of 2000 and in Mesquite in January of 2008. Our mobile clinic launched in the fall of 2020 and visits Pleasant Grove, Garland, Royse City and Terrell.

We see approximately 1600 clients per year from all over the DFW metroplex. We are a free clinic that is funded through the generosity of our community and annual fundraising events.

Our Mobile unit costs approximately \$17,000 to operate 2 days a week for a year.

The PRC served 5 Sunnyvale girls in 2020. So far this year, the PRC has helped 3 clients from Sunnyvale. We are the closest free and confidential clinic and our Mesquite office is within 5 miles of Sunnyvale High School.

We are hopeful that this donation would allow us the opportunity to serve more clients as well as raise awareness about the services we provide. As Sunnyvale continues to grow we hope to grow our presence as well.

The mobile clinic allows us to bring our services to clients that may not otherwise have access to our Rockwall or Mesquite locations.

Over 500 women will benefit from our clinic going to them instead of them having travel or transportation issues in getting to us.

This gift would cover operational expenses for 2 days a week for the 2022-2023 fiscal year.
